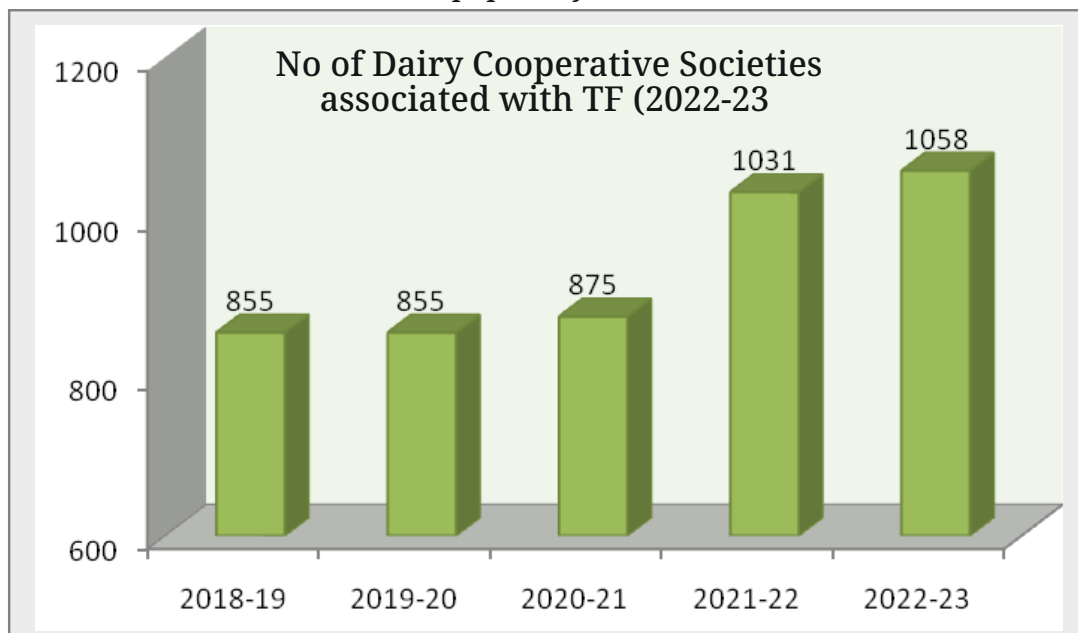

Tribhuvandas Foundation (A Unique Co-operative Linked Health Care NGO in Central Gujarat):

Cooperative based health delivery model is gradually gaining its importance in the last few years. A healthcare system should commit to provide ethical, reliable and cost-effective services. Recent Covid pandemic has proved that community participation is the key to success of any health care model. Pandemic has badly exposed the lack of sustainability of the healthcare system in the wake of challenges posed by an increase in demand for health services. The resultant rise in health care expenditure as a result of this has further burdened our health care system

Establishment of “Amul” co-operative was the historical landmark in India around the time our country became independent. Since then “AMUL” has created a benchmark by running successful milk cooperative in the world. White Revolution made AMUL and the cooperative model popular. A farmer’s movement, initiated by Shree Tribhuvandas Kishibhai Patel, has now been turned into one of the world’s largest milk cooperative. After having success in the dairy sector in Gujarat, Shri Tribhuvandas Patel initiated a cooperative linked health care programme in Central Gujarat with the name of ‘Tribhuvandas Foundation’, an NGO, in the year 1975 as an integrated rural health programme. Tribhuvandas Foundation focuses on the health of mothers and children and on primary care. The foundation is committed to provide home based healthcare to mothers and children in the villages under its fold. The sustainability of Tribhuvandas Foundation is due to its cooperative linked activities and finance mechanism. Particularly during the Covid-19 epidemic and subsequently, home based – family centred care has emerged as a very important aspect of health care that has been neglected so far.

The foundation is linked with dairy farmers (villagers) through local dairy cooperative societies at village level. Concerned with the poor state of health of mothers and children, the founder Shri Tribhuvandas Kishibhai Patel (popularly known as Tribhuvankaka), initiated the foundation with a



vision of serving health and nutrition needs of mothers and children in the erstwhile Kheda district. The villages under original Kheda district are now distributed over Anand, Kheda and Mahisagar districts. Thus, TF covers Anand, Kheda and part (Balasinor and

Virpur blocks) of Mahisagar districts. The foundation is working closely with the village level Dairy Cooperative Societies (DCS) – the village level units which are linked with AMUL, India. TF, in association with the local dairy cooperative identifies a local woman who is willing to serve on voluntary basis.

Village Health Volunteers (VHV):

Tribhuvandas Foundation is meant to provide a primary level care to mothers and children to improve their health and nutritional status. To achieve this goal, it was essential for TF to involve the community at village level. To encourage community participation and to put people's health in people's hand, TF adopted a unique health care delivery model. TF started identifying one local woman from each of the associated villages and started providing them training on selected health and nutritional aspects. Under the supervision of TF's staff such women started working for mother and child health in their respective villages. Such Voluntary Health Workers are recognized as Village Health Volunteers 'VHVs' of Tribhuvandas Foundation. They are the grass root level workers and working very closely with the community. These workers are also getting monthly honorarium from the local DCS.

Community Health Program:

TF has established a community based Maternal and Child health program in association with Dairy Cooperative Societies. In all, 1062 villages (DCS) have accepted TF and helped TF initiate this programme by 31st March 2023. Promotion of early initiation of breastfeeding, exclusive breast feeding and Kangaroo Mother Care (Facility and Community based) are few of the key areas. Early identification and referral of at-risk antenatal / post-natal mothers and newborn are also some of the important activities. Over the years, TF has also focused on activities like Garbhasanskar and Mental health of mothers. TF has developed a comprehensive tool to implement all these activities.

'Jatan' – A Comprehensive Mother and Child Care Program:

This is a comprehensive, structured, community based maternal and child health care programme of TF which also incorporates maternal mental health. Jatan means “nurture”. This program is also linked with incentives to TF's VHVs. Physical aspects of health care of mothers and children remain important for reducing the maternal and infant mortality rates. These include very well-established low cost interventions as shown below –

1. For mothers –

- o Early identification of pregnancy
- o Regular antenatal check up
- o Provision of Iron folic and calcium tablets
- o Tetanus vaccination

- o Identification of risk factors and appropriate management of high-risk pregnancy
- o Ensuring institutional deliveries (now much easier because of government schemes)

2. For infants –

- o Essential New-born Care
- o Immunization
- o Breast feeding and complementary feeding
- o Treatment of common illnesses

However, to further improve the care of mothers and children, following aspects of maternal and child health care also need to be taken care of.

• During antenatal period

- o Adequate preparation for birth (delivery)
- o Adequate preparation for breast feeding
- o Adequate preparation for Kangaroo Mother Care
- o Mental health of mothers (During pregnancy and after delivery)

• After delivery

- o Adequate postnatal care of mothers including mental health
- o Kangaroo Mother Care for Low-Birth-Weight new-borns
- o Improving feeding practices – both breast feeding and complementary feeding
- o Development of the infant
- o Improve nutrition of mother and newborn

Mental health of the mothers is now considered very important and it is well established that mothers with depression not only have more frequent physical problems but their infants also have more frequent illnesses and their care (like immunizations, treatment of illnesses) and development are also affected. Moreover, home based care of mothers and children is as important as institutional care. Improvement in home-based care practices needs constant efforts in a systematic way.

Garbhasanskar :

Garbhsanskar means educating the mind in womb. It is believed that child's mental and behavioural development starts in the womb. It is influenced by mother's emotional state. This traditional concept is now accepted by modern science as well. TF has integrated all the Garbhasanskar activities in their field programme. At present the focus is on education of mothers on various Garbhasanskar activities that can be carried out at home. Under this selected employees of TF have been trained as Trainers and have learnt the perspective of Garbhasanskar and its various activities and its benefits to the mothers and the baby. TF is now committed to incorporate these activities at its centres and in Community Health Programs. Various pilot activities have been tested and strengthened during the year.



Shishu Sangopan :

Kangaroo Mother Care is an evidence based and rational intervention for low birth weight babies and as per the policy guidelines from the ministry of health and welfare (GOI) it needs to be widely promoted among all the health care delivery systems. Under this project, TF has started with the training of VHWs who can support Home Based KMC systematically in their villages. Accordingly, 30 villages each from Anand, Kapadvanj and Balasinor centers (Total 90 villages) have been selected and their VHWs provided training on Home Based KMC. Two field workers from each of these three centres have been given responsibility to monitor this activity in their respective areas. In all, 104 low birth weight babies have been successfully given Home Based KMC (HBKMC) under this project during the year. In time to come, gaining practical experience of running this unique programme, TF would like to train more VHWs for Home Based KMC. This will also help in improving quality of HBKMC.

TF has also presented its experience on HBKMC at various platforms particularly in academic events and conferences organized by Kangaroo Mother Care Foundation, India and allied associations.

Handicraft Unit :

Since inception TF closely works with women and has been supportive to them. Generating livelihood opportunities especially for women is always a challenge. TF has established a handicraft unit to support women by providing livelihood opportunity through this unit. Herein, the women are engaged in traditional cloth-based appliqué work known as “Patchwork”. Apart from this TF also provides platform to women associated with it to showcase their other handicraft skills. Work based incentives are provided to women. TF encourages rural women to learn patchwork by training them free of cost. Later, these women are enrolled by the handicraft unit and are provided work and hence the opportunity for income generation. The trained women can do patchwork at home during their spare time. So their routine life is not affected and they can earn depending upon the quantum of work they do.

TF is also planning to upgrade-support handicraft unit by setting up a small scale manufacturing unit for making reusable sanitary pad. Necessary training of the staff has already been carried out and manufacturing of reusable sanitary pad has also started on pilot basis.

During the year TF participated in the Handicraft Fairs as mentioned below -

1. Handicraft fair organized by National Cooperative Union at New Delhi from 14th to 20th November

2. An exhibition-cum-sale organized by NABARD at Ahmedabad from 11th to 13th March 2023

During Diwali season TF also organized an exhibition-cum-sale at its premises.

Maternal and Child Care – Clinical services :

The organization is running maternity homes and offering paediatric care at Anand and Kapadvanj centers where basic obstetric care like normal deliveries and deliveries by caesarean section and primary care of new born and children are available at very affordable rates through Gynecologists and Pediatricians respectively. In addition, there is a level 2 newborn care facility at Kapadvanj centre (Supported by Doctor Charitable trust, USA).

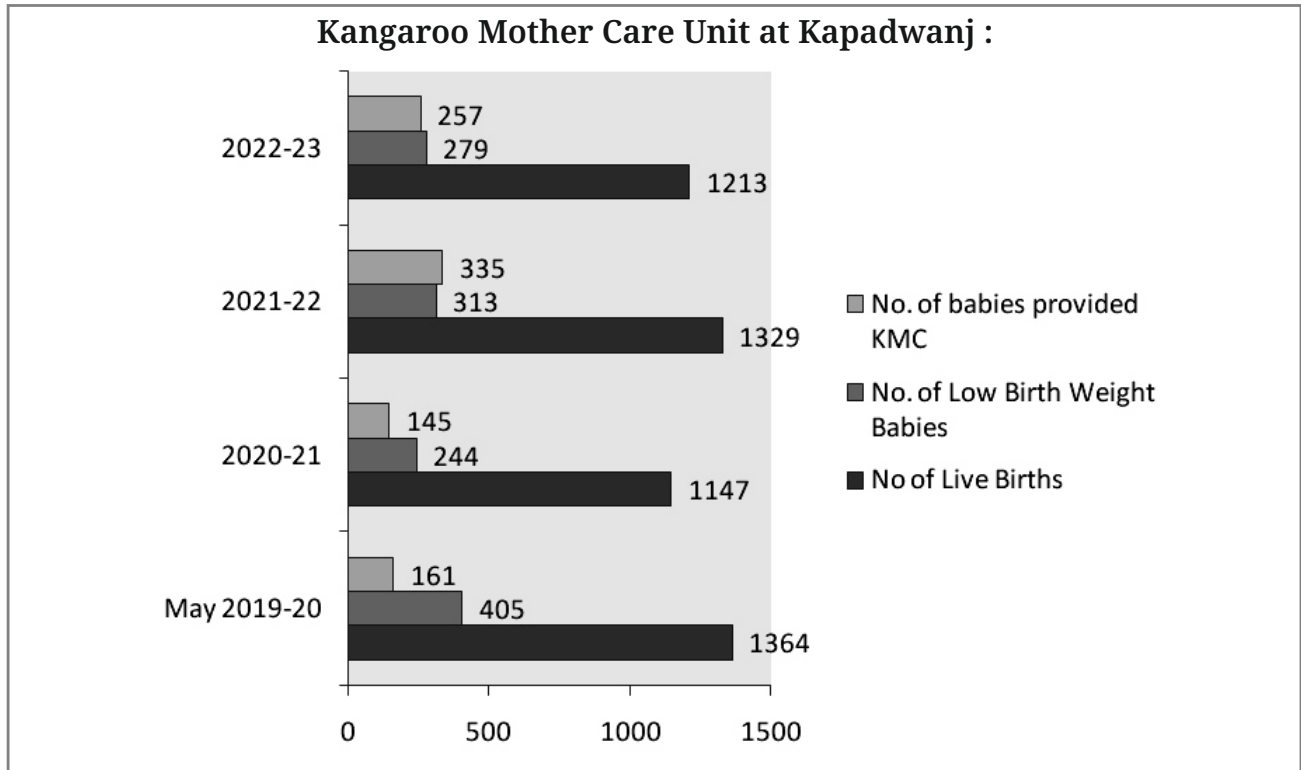

Obstetric Ultra Sonography (USG) Services:

At present TF is offering an ultra-sonography service to antenatal mothers at nominal rates at Anand, Kapadvanj and Tarapur Centres. Ultra Sonography machine at Anand center is made available from the “LIC Golden Jubilee Fund.”

Shrimati Sumatiben Trivedi Kangaroo Mother Care Unit, Kapadvanj (Facility Based Kangaroo Mother Care Unit)

TF has been working for promotion of Kangaroo Mother Care for low birth weight babies and premature babies since long. It is essential to start KMC immediately after birth at the facility and continue the same at home after discharge. It is desirable that newly delivered mother gets enough training and support for providing KMC to her LBW baby in initial few days. Such motivated and supported mother continues the same at home also. Therefore, TF has set up a facility-based Kangaroo Mother Care Unit at its Kapadvanj centre in May 2019 with a generous donation received from Trivedi Family, Vadodara. This unit is specially designed to support mothers who are motivated to provide KMC to their low birth weight newborn babies. A trained counsellor and a nurse are providing services round the clock in this unit under the guidance of a Pediatrician. All the mothers having delivered low birth weight babies at Kapadvanj centre of TF are counselled to stay in this specially designed unit. The mothers are then taught in detail about methods of KMC / Breastfeeding & basic newborn care. Mothers and family members are also educated to continue Kangaroo Mother Care at home after discharge. This part of KMC is supervised by the VHVs of TF. Thus, this unit is linked with the community for Kangaroo Mother Care. Out of total 1225 deliveries and 1213 live births reported in Kapadvanj centre during the year, 279(23%) newborns were LBW (< 2.5 kg). Kangaroo Mother Care unit admitted 257 (92.11%) LBW babies during the year 22-23.



Primary Care Clinics

With the aim of providing rational and affordable primary care through doctors in case of need, TF runs clinics at five centres – Anand, Kheda, Kapadwanj, Balasinor and Tarapur. Patients are also counselled on preventive care in such clinics. With nominal case registration charges, low cost of investigations and medications the overall cost of care remains affordable for the lower socioeconomic groups.

The table below indicates number of patients who availed primary care services at TF clinics:

Over & above its regular clinics at five centres, TF is running once-a-week field OPDs at Boriavi, Samarkha, Sojitra, Sanjaya, Petlad, Virpur and Dakor. In all, 2282 patients availed services during the year 2022 – 2023, through these field OPDs.

Diagnostic Laboratory Diagnostic services at TF:

TF is also providing laboratory services at affordable rates with a unique concept called 'Virtual Laboratory'. At virtual laboratory, tests are done by trained laboratory technicians with the use of modern auto-analysers and the reports are verified and authenticated by qualified pathologist via internet who also inserts expert comments. This unique concept not only provides good quality laboratory services at remote rural centres but also reduces the cost of laboratory tests significantly.

Few essential tests that cannot be performed at the virtual laboratory are also outsourced to nearby laboratories.

Additional Clinical Services

- (a) Non-Communicable Disease (NCD) Clinic** :To provide quality treatment of Non Communicable Diseases (NCDs) like High Blood Pressure and Diabetes, to patients coming from rural areas, TF is running an NCD clinic daily at Anand centre and fortnightly at Kheda centre. At both these centres ECG facility is also available. TF is also providing its Physician's service to J.S. Ayurveda Mahavidyalaya & P.D. Patel Ayurveda Hospital, Nadiad on weekly basis. During these visits, apart from providing clinical services, the Physician also conducts teaching sessions for PG students of Ayurvedic College
- (b) Homeopathy OPD** –TF has been running a weekly homeopathy OPD since October 2020 with the help of a visiting homeopathy MD consultant from Anand Homeopathy College. During the year 2022 – 2023 total 818 patients were treated in the Homeopathy OPD..
- (c) Ayurvedic OPD:** Basic Ayurvedic drugs are already provided in TF's community-based health programme for many years. With increasing awareness about Ayurved, TF started weekly Ayurvedic OPD at Anand Centre in January 2022 with the help of a visiting Ayurvedic consultant from P.D. Patel Ayurveda Hospital, Nadiad. During the year 2022 – 2023, total 386 patients were treated in the Ayurved OPD
- (d) Physiotherapy services:** TF is providing basic Physiotherapy services at affordable cost at its Anand & Kheda centres as well as at Mahemdavad, through a Physiotherapist. Total 7481 patients were treated in physiotherapy clinics in the year 2022-23.
- (e) Dental Service:** TF is running a dental clinic with the help of a dentist at TF's Anand centre for more than ten years. Total 8161 patients availed dental services in the year 2022-23..
- (f) Skin OPD** : A Dermatologist is giving his services as visiting Skin specialist, at Kapadwanj centre

of TF, twice a week. Total 4952 patients availed his service in the year 2022-23..

Collaboration with the Nutrition International (Canada)

Tribhuvandas Foundation is actively working with the Nutrition International (Canada) in two projects across Gujarat since 2021 –

Birth Package Programme (BPP) : Under this program, TF, along with the Nutrition International (Canada) is supporting 10 districts of Gujarat (Anand, Dahod, Panchmahal, Rajkot, Jamnagar, Junagadh, Bharuch, Surat, Vadodara and Narmada) with the objective of improving the government services for mother and new born. In all, 293 functional delivery points and labor rooms of Govt. Health Centres were visited and various strengthening activities were carried out. The project team also monitored VHND sessions in these districts. Mentoring of 5 Technical Resource Centers has also been undertaken.

Adolescent Nutrition (AN) project to improve the nutritional status of adolescents- This project covers 15 districts of Gujarat. It covers both the school going and also out of school adolescents. This project involves liaisoning with Health, ICDS and Education functionaries and also awareness activities. So far, 5 Workshops have been conducted for District Pharmacists under this program to improve the logistics, (strengthen supply chain management of Iron and Folic Acid).

Childline 1098

The foundation is running two help lines for children - Childline (Dial no. 1098) for Anand city and a Childline help desk at Anand railway station (Railway Childline), in association with the Childline Foundation, India and Ministry of Women and Child Development (MoWCD).

The purpose of this service is providing support to the vulnerable children. The common problems encountered include child begging, domestic violence, child labour etc. Whenever a call regarding vulnerable child / children is received on '1098', the team immediately reaches the site and provides support to the affected child / children. In doing so, help may be needed from the District Child Protection Unit, Anand, Local and Railway police, Anand etc. Sometimes the issue could be a neglect of a child. Depending on the needs in individual cases, appropriate actions are taken by the team. In addition, through outreach programmes, awareness activities are also carried out on regular basis

Projects under Corporate Social Responsibility

Tornascent (Torrent Group of Companies) has supported activities at Balasinor centre. A pediatric clinic is being run at Balasinor with the support from Tornascent group.

Taruni :- Under this project, 2000 adolescent girls from villages around Anand, Balasinor and Kapadvanj centres of TF were educated on menstrual health and hygiene and were given sanitary pads free of cost for one year with the support from Omori, India at Anand center and Suyog Electricals, Vadodara at Balasinor and Kapadvanj center.

Nutrimilk : TF could restart the Nutrimilk project (supported by Alltech India) after the pandemic as schools reopened in March 2022. 1620 children from 10 schools, covered under this project, were given nutrient rich milk on daily basis.

Samvardhan : In view of the emerging need to promote Organic farming, TF has started developing capacity building of farmers under this project. This project is supported by SAP India and WHH Germany. So far 90 farmers (including 20 lead farmers) have been trained on Organic Farming during April 22 to March 23. With the help of lead farmers 18 Farmers' Field Schools have been initiated in which lead farmers are training other farmers in their respective villages. Apart from this, 329 (243 women and 86 men) farmers have received sensitization training on nutri garden and organic farming activities.

Clean Wings : Women's menstrual health and hygiene are often neglected specially among rural adolescent girls in our country. TF has taken up this challenge and has been providing pertinent health education to girls. Apart from the awareness drive, it also continued to provide sanitary pads during the year. Under this project 11135 packs of sanitary pads were given along with educational material for menstrual health and hygiene.

Capacity Building of Health Workers and Health Professionals

- o Monthly training of TF health workers in 226 batches conducted at various centres of Tribhuvandas Foundation during the year
- o Periodic training of government health workers in different batches conducted at Anand centre of Tribhuvandas Foundation during the year
- o All Medical Officers of TF receive twice a month online training to provide them updated knowledge and enhance their skills
- o Training of Government health workers and staff in various program districts of Gujarat under NI projects

Report on the Audit of the Financial Statements

Opinion

Basis for Opinion

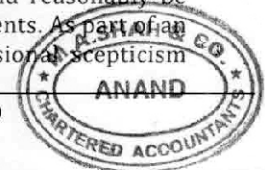
